- 7. Please note: It is your responsibility to fill out the form correctly. We will not double check the information you provide. If the transfer cannot be processed due to incorrect information, the transfer fees will still be deducted from your deposit. Our bank (Sparkasse) charges 13 € for their service. Additional fees may/will be charged by your international bank.
- 8. The deposit will be refunded no later than 3 month after the end of the contract. Provided that no problem was noted in the moving out documents. Any kind of issue can delay the refund.

## **Guidelines**

## Beneficiary IBAN / Account-Number:

For countries with IBAN, it is mandatory to fill in IBAN. It is not sufficient to give only the account number. Please note, some countries do have IBAN, although they do not accept SEPA-transfers.

#### Name of account holder:

Please insert the name of the account holder exactly! Please mind the correct spelling. (Especially important if account holder and tenant are not the same).

# Payments to USA:

If your beneficiary bank is in the USA, please insert the 9 digit ABA-Routing-Number or Fedwire-Number in the reference field.

### Payments to India:

It is mandatory to note the Purpose-Code: P1306 in the reference field.
